<u>Certified Survey Map to Combine 2 Existing Parcels on Lakeview Drive – Okauchee Lake – Requested by William & Gail Fons – Tax Keys MRTT0406-003 & MRTT0406-004</u> –Haroldson stated they want to combine the two lots so they can tear down the house and build a new one. There are several additions and changes that need to be made. Waukesha County has not reviewed this certified survey map.

A motion to conditionally approve with a recommendation to the Town Board for approval and signatures after receiving the final CSM with the recommended changes from the Town and Waukesha County Parks & Land Use was made by Siepmann/Jensen. Motion carried.

<u>Certified Survey Map to Divide a 3-Acre Parcel from the 84.5 Acres +/- Acres on Hoff Road – Requested by Jim & Mary Ellen Berkholtz – Tax Key MRTT0293-998</u> – Haroldson stated they have 84 acres and they want to split off a 3-acre parcel. The certified survey meets the ordinances. There are a few things that need to be added or corrected.

A motion to recommend to the Town Board for approval of the Certified Survey Map contingent upon receipt of a CSM with changes to the map as recommended by the Town, prior to signing the final recordable CSM was made by Jensen/Griffin. Motion carried.

Request for Increased Building Height to 19'4" for an Accessory Structure – Theresa Marie Drive – Requested by Ralph & Sue Schneider – Tax Key MRTT0333-001-001 – Haroldson stated this would be their second accessory structure and it meets the offsets. They're asking for a height of 19'4". Sue Schneider stated the existing barn is 19'10".

A motion to approve the height allowance for the new building was made by Good/Siepmann. Motion carried.
